“2008 was another year of significant growth for I.R.I.S. and we will set new records. Although, we will not release our annual results until March 17, 2009 after completion of the closing and audit work, we can already announce the general trend for fiscal year 2008. Revenue will be in excess of EUR 108 million, up 14% and gross margin, in excess of EUR 55 million, up 16% compared to 2007. As a result, we expect a record EBITDA (cash flow from operations) in 2008. The sales growth is well balanced between organic growth and the contribution of our Dutch and German subsidiaries (acquired at the end of 2007). Besides these acquisitions, that proved to be smart moves, I.R.I.S. has set up new subsidiaries in Hong Kong and Scandinavia to broaden the client base in Asia and Europe.”

Group declares: *“The management is quite pleased to report these good results, achieved despite difficult market conditions. 2009 will be a challenging year, but the management still expects to grow the business and maintain a solid EBITDA and profitability. A sixth dividend will be proposed to the annual shareholders’ meeting.”*
