In this Newsletter, we are reporting our 2009 results.

I.R.I.S. confirms a satisfactory level of business for the year 2009, despite a very difficult environment. As announced since May 2009, the FY2009 result is lower than in FY2008. This is attributable to the financial crisis. I.R.I.S. has however maintained all strategic initiatives. We closed the year with a cash flow from operations (EBITDA) of € 7.1 million (vs. € 9.8 million in 2008), which is considered a good performance in these turbulent times. Our balance sheet is still as solid as one year ago.

In this release, we're also introducing you to some new technologies.

We also invite you to participate virtually to the 2010 IRISLINK, our annual partner's event. It was extremely successful and got a significant focus from our partners. Our website has a dedicated section www.iriscorporate.com/irislink2010 that summarizes some of the key moments of the event and allows you to envision how to empower business through intelligent document capture, enterprise content management and optimized IT infrastructure. Although it remains difficult to make reliable short-term forecasts in the current environment, we are confident that I.R.I.S. will deliver growth of sales and profit in 2010-2011 thanks to the numerous initiatives that we outline in this newsletter.

Consistently with our dividend policy, we shall propose to the annual Shareholder's meeting of May 18, 2010 a dividend of 0.47 €/share.
