As communicated a few weeks ago, we have been very happy to announce the investment made by CANON in I.R.I.S. Group whereby CANON, a world-wide leader in Professional scanners and Digital Copiers acquired 17% of the shares of our company.

We believe that this is a very positive step for our Group and we truly believe that this provides I.R.I.S. with a great opportunity. CANON is committed to developing its existing business partnership with I.R.I.S. on an EMEA basis, in the area of products and solutions sales. In addition, CANON is also interested in the expertise of I.R.I.S in large scale ECM solutions projects, particularly in pan European accounts. We are looking forward to developing a closer commercial relationship between each other which ultimately shall increase the value of our company. We expect a lot of positive benefits from this collaboration in the future.

In July, we also announced the signature of a framework contract with the SNCB/NMBS (Belgian National Railway) covering their future projects in ECM (Electronic Content Management). The proposed agreement combines the strengths of both our divisions; indeed, it covers a wide spectrum of services (from Organizational consultancy to Architecture and design of solutions as well as change management and of course process analysis, design and software configuration). It is also offering some of our most recent proprietary technologies such as IRISPowerscan™ (scanning of paper documents and indexing of electronic documents); IRISDocument Server (i.e. intelligent compression of digital documents with I.R.I.S.' iHQC™ technology) and IRIS XTract for Documents (automatic processing of invoices, automatic classification).

You will also find other information regarding major agreements (signed with EVIDES, TEC Charleroi, BAHR, etc.) and new products releases.

## Investor newsletter 29 – August 27, 2009

The first part of this newsletter is dedicated to the presentation of our half-year results. During the first half of the year the Gross Margin did grow by 5% and although the profitability is down from last year (it is important to remember that for the first 6 months of 2008, the profit from operations was exceptionally high) the company delivers a satisfactory performance with an EBITDA of 3.8 million for the first six months.

This is a good achievement in such an adverse economical background and compared to the average performance of the IT market. It indicates a strong resilience of our company products, explained by the fact that our solutions provide our clients with cost reduction and quick return on investment.

However, the company needed to manage its costs very carefully during the first half-year and will continue to monitor its operating expenses very carefully in the coming months in order to optimize the profitability and manage properly the operational risks.

Our balance sheet remains solid and our Net equity has increase due to the profit posted over this period.
