## 1. Introduction

This User Guide helps you get started with the **IRIScan™ Executive 4**, a mobile duplex scanner.

It is compatible with Windows only.

The default scan settings of the IRIScan™ Executive 4 are the following:

- Duplex mode
- Color
- 300 dpi  
Its maximum resolution is 600 dpi.

Please read this guide before operating this scanner and its software. All information is subject to change without prior notice.

## 2. Software Installation

### 2.1 Important Notes

- Install the software before you connect the scanner to your computer.
- Check the System Requirements on the [I.R.I.S. website](#) to make sure your system is compatible.

### 2.2 Precautions

- Keep the scanner out of direct sunlight. Direct exposure to the sun or excessive heat may cause damage to the unit.
- Do not install the scanner in a humid or dusty place.
- Be sure to use the proper AC power source.
- Place the scanner securely on an even, flat surface. Tilted or uneven surfaces may cause mechanical or paper-feeding problems.
- Retain the scanner box and packing materials for shipping purposes.

### 2.3 Installation

1. Go to [www.irislink.com/start](http://www.irislink.com/start).
2. Scroll down to **IRIScan™ Executive 4** and click the **Download** button.
3. Once the download is complete, run the **IRIScanExecutive4.exe** file.
4. The following setup screen is displayed:




5. Click "**Readiris™ Corporate**" to install Readiris. Follow the on-screen instructions.

**WARNING:** make sure to install this version of Readiris™ Corporate. Other versions of Readiris™ are not guaranteed to work with the Button Manager software.

6. Return to the setup screen and click "**IRIScan™ Executive Driver**" to install the scanner driver.

7. Click "**Next**" until you reach the step "**Plug in the USB Cable**".
  - Connect the micro USB connector to the USB port of the scanner.
  - Connect the other end of the USB connector to a USB port on your computer.



8. When the driver is successfully installed the following message appears: "**This device is now ready to use**".
9. Click "**Finish**" and return to the setup screen.
10. Click "**Button Manager**" to install the Button Manager. A language selection window appears.



11. Choose the language you wish to install. The InstallShield wizard guides you through the rest of the installation.




12. Click "**Finish**" to complete the installation.
13. Click "**Cardiris™**" to install Cardiris™. Follow the on-screen instructions.


**Attention:** only use the USB cable delivered with your scanner. Using other USB power adapters may damage the scanner and void the warranty.

## 2.4 Activation

The license numbers required to activate **Readiris™** and **Cardiris™** will be retrieved automatically on the condition that your scanner is connected to your computer by USB during activation process.

## 3. Supported Documents

### 3.1 Suitable Documents

The scanner is designed to obtain the best scanning results with the following types of originals:

- Photos and documents (3"x5", 4"x6", 5"x7", 8.5"x14") (76 x 127mm, 102 x 152 mm, 127 x 177 mm, 216 x 356 mm)
- Business cards [standard 3.5"x 2" (88 x 50 mm) or larger]
- Long page (8.5"x36") (216 x 914 mm) for 300 dpi only
- Paper Weight: 60~107 g/m<sup>2</sup> (16~28 lb)


### 3.2 Unsuitable Documents

Do **not** use the following types of originals for scanning, or the scanner may malfunction or cause the original to jam in the slot.

- Originals thicker than 0.8 mm
- Originals with either side shorter than 50 mm
- Originals with lots of black or dark colors
- Originals with dark colors surrounding the edges
- Printed media (newspapers, magazines, etc.)
- Soft and thin materials (thin paper, cloth, etc.)
- Originals that exceed 14 inches long and 8.5 inches wide (for 600 dpi)

## 4. Using the Scanner

### 4.1 Top view



Item	Name	Description
1	Micro USB port	Connect to a computer via the micro USB cable.
2	Feed slot	Insert document into the feed slot: <ul style="list-style-type: none"> <li>• Face <b>UP</b></li> <li>• Aligned with the <b>LEFT</b> edge to begin scanning.</li> </ul>
3	Power/Scanner button	Press and hold for 3 seconds to power on/off. The blue led lights up and stays on when the scanner is powered on. Press once to scan. <b>Warning:</b> the scanner must be connected to a computer to power it on and to scan.

### 4.2 Led info

Blue led, on.	Scanner is powered on.
Blue led, blinking.	Scan in progress.
Green led, blinking fast.	Scan error or paper jam.
Led is off.	Scanner is powered off. <b>Notes:</b> When the scanner is idle for 240 minutes it auto powers off. When your computer is not connected to a power source and you put it to Hibernate the blue led turns off.

## 4.3 Scanning with the IRIScan™ Executive 4

The IRIScan Executive 4 can be used in several ways:

- With the **Button Manager** to scan documents directly to Readiris for text recognition, scan them to other applications of your choice, to multiple Cloud destinations, etc.
- From within **Readiris™** or **Cardiris™**.

In this User Guide we only describe the basics how to scan.

Separate User Guides are available for the Button Manager, Readiris and Cardiris.

### 4.3.1 Basic Scanning

#### **WARNING!**

- Insert only one page at a time, and insert the next one only when the previous one is done. Otherwise, the scanner may malfunction.
- The paper detector is quite sensitive. Please do not push your document into the feeding slot or the top of your image will be cut. Simply let go the document when it begins to feed into the slot.

1. Connect the scanner to your computer using the provided USB cable.  
The scanner is powered on automatically.
2. Insert your document **FACE UP** into the feeder and align it to the **LEFT** edge of the feeder.




3. Gently push the document into the feed slot.
4. Press the **Scanner** button once to start scanning. The document will be sent to the default destination of the Button Manager.

**Note:** it takes a few seconds for the scanner to start.

### 4.3.2 Scanning like an ADF (Automatic Document Feeder)


The IRIScan™ Executive 4 can also be used as an ADF in which you insert one sheet after the other without having to click or press Scan every time.

1. Start the Button Manager from **All Programs > IRIS Button Manager**.
2. Right-click the button you want to use.




3. Select **Use Twain** next to **Advanced Settings**, and click **OK** to confirm.

**TIP:** to remove Blank pages from your scans, click the **Setup** button next to **Use Twain**. Click the **Separation** tab and select **Blank Page Removal Threshold**. The more you move the slider to the left, the sooner a page will be considered blank.



4. Now insert a page into the scanner and click the button you configured.
5. Once the page has been fed through a message appears informing you you have 15 seconds to insert another page.
6. Insert the other pages you want to scan one by one.




7. When you are done scanning all your pages, click **Cancel**.

## 5. Maintenance

### 5.1 Calibrate the scanner

Calibrate only if the scanned image looks fuzzy, the color looks abnormal (e.g., darker than normal), after more than 8,000 scans, or the scanner has been stored without use for a long time. The calibration process resets the Contact Image Sensor to resume its color and sharpness precision.

1. Connect the scanner to your computer.
2. Start the **Capture Tool**.
  - Click **Start > All Programs > IRIS IRIScan Executive 4 Scanner > Capture Tool**
  - Select your driver type and scanner model and click **OK**.



3. The Capture Tool dialog box will be displayed.
4. Click the **Setup** button to open the Scanner Properties dialog box.
5. Click the **Settings** tab and then click the **Calibration** button.
6. The **Insert calibration sheet** dialog box appears.
7. Hold the edges of the calibration sheet (*included*) and insert it with the text *facing up* and the white area feeding first into the feeder (As shown below).



8. Click **OK** in the **Insert calibration sheet** dialog box to start calibrating the scanner.

**WARNING:** If the calibration failed, the led will be flashing and an error message will be displayed on the screen. Disconnect and reconnect the scanner and then repeat the calibration.


## 5.2 Cleaning the scanner

In order to maintain an optimal scan quality and prevent dust accumulation, it is recommended you clean the scanner (*outer casing and feed rollers*) approximately every 200 scans, or if vertical lines or stripes appear on the scanned image.

- Use only the recommended and supplied tools to clean the scanner.

**WARNING:** Do not use any solvents or corrosive liquid (*i.e., alcohol, kerosene, etc.*) to clean any part of the scanner, otherwise the plastic material may be permanently damaged.

1. Open the cover by holding the scanner with one thumb on the feeder and another thumb on the cover. Carefully and firmly press your thumb into the feeder and then raise the cover. This will cause the top of the scanner to release from the bottom of the scanner.
2. Gently wipe the glass and feed rollers on the scanner, and the CIS cover with the cleaning cloth (*included*).



## 6. Troubleshooting

### 6.1 Clearing a Paper Jam

When a document is jammed inside the feeder the scanner led blinks green.

To clear a jam from the feeder, press and hold the Power button for 3 seconds to power off, then press quickly to power on again. The jammed document will be fed through automatically.



If the document is still jammed, follow these steps to remove it:

1. Open the cover by holding the scanner with one thumb on the feeder and another thumb on the cover. Carefully and firmly press your thumb into the feeder and then raise the cover. This will cause the top of the scanner to release from the bottom of the scanner.



2. Remove the item.



3. Close the cover and reinsert the item to rescan.

## 6.2 Questions and Answers

<b>Question:</b>	<b>Why doesn't my scanner power on</b>
<b>Answer:</b>	Make sure the scanner is connected to your computer using the provided USB cable.
<b>Question:</b>	<b>Why does my scanned image always come out too dark?</b>
<b>Answer:</b>	<ol style="list-style-type: none"> <li>1. Please adjust the screen settings to SRGB.</li> <li>2. Please adjust the brightness settings on the screen from application software.</li> </ol>
<b>Question:</b>	<b>Why are there strange lines on the scanned document?</b>
<b>Answer:</b>	<p>Please check the following:</p> <ol style="list-style-type: none"> <li>1. Are there scratches on the original or is the original clean ?</li> <li>2. Remove any stains or dust from the original before scanning.</li> <li>3. Clean the rollers and glass with the included cleaning cloth. (Refer to the section "Clean the scanner")</li> </ol>
<b>Question:</b>	<b>When I choose 600 dpi as optical resolution, why are the "auto crop" and "deskew" functions disabled?</b>
<b>Answer:</b>	Since performing auto crop and deskew consumes great deal of system memory, it is recommended to select an optical resolution below 600 dpi to prevent errors.
<b>Question:</b>	<b>Should the scanner feel warm to the touch?</b>
<b>Answer:</b>	It is normal for the scanner to emit a small amount of heat after prolonged use. However, if there are strange odors coming from the scanner or the scanner feels a little bit hot to the touch, turn the scanner off immediately.
